RGGI, Inc. Milestones Update

Mr. McKeon provided a summary of the RGGI, Inc. milestones including:

- The 2019 Proceeds Report was released in June 2021. This report is another annual report that provides insight into how the RGGI states have utilized the proceeds they have received through the quarterly RGGI auctions and provides some interesting success stories of local initiatives funded by the states' RGGI proceeds.
- Working with the RGGI states, in March we processed the full three-year compliance for the Fourth control period (years 2018 through 2020). Compliance was over 99%, showing the continued success of the process.
- We have completed four auctions this year, reaching the milestone of our 54th consecutive successful auction just this week.
- RGGI Inc. in 2021 continued to provide guidance and answer questions from the PA DEP and from Pennsylvania stakeholders in light of the potential participation by Pennsylvania in RGGI.
- We welcomed the Commonwealth of Virginia as a RGGI Participating State on January 1st. With the addition of Virginia, the eleven RGGI participating states together represent an economic size equivalent to the fourth largest economy in the world.
